### **Minutes of a Meeting of the Council Meeting held on 1<sup>st</sup> June 2016 at Carnegie Hall.**

#### **511: To receive Declarations of Interest.**

Cllr J Thomas declared an interest in item 514 and did not take part in the discussions. Additionally, it was noted that no Member that had declared an interest in the last meeting took any part in the approval of the minutes for that meeting.

**Late Application: P2016/0420 – Two storey and single storey rear extensions. 3 Stanley Road, Skewen.**

**Late Application: P2016/0456 – Retention and completion of works to facilitate the temporary construction of access track and associated works (permission for a temporary period of 18 months, within a maximum of 12 weeks use would be permitted) plus the regularisation of works to trees protected by a Tree Preservation Order together with site clearance works and ecological mitigation/compensation. Land South of Coed Darcy, Former BP Refinery. (Applicant – Mr R Joseland – Agent).**

The Members strongly objected to the above Planning Application for the following reasons:

St Modwen have already breached Planning Conditions by starting work to clear the area, including the destruction of trees protected by Tree Preservation Orders. The Members all agreed that St Modwen should be prosecuted for these actions. The Members strongly believe that it is unacceptable for large Development Companies to get away with this type of breach in Planning Legislation, when any individual would get prosecuted.

The Members are very concerned about the impact this development would have in what is a very sensitive area for wildlife. It was noted that this area is in very close proximity to a SSSI. The Members reported on a recent BBC programme which was filmed in the area, which identified several new species of insects. It was stated that the wildlife does not know where the SSSI boundaries are, and that it is inevitable that some wildlife will enter the development area.

The Members are also very concerned about the impact the access track could have on the Towers Hotel and the local residents. The Members are concerned about the noise pollution that construction Lorries would cause.

The Members strongly objected to any further trees that are protected by TPO's being cut down, and to any development in the area.

The Clerk was asked to request that if the Planning Department were to approve the above Planning Application against the wishes of the Community Council, that the Planning Department ensure that there is very strict enforcement in any conditions imposed by the Planning Department, with regular visits from Enforcement Officers.
