### **Minutes of a Meeting of the Council Meeting held on 1<sup>st</sup> April 2015 at Carnegie Hall.**

#### **10,074: To receive Declarations of Interest.**

Cllrs K Whitehead-Ross and I Whitehead-Ross declared an interest in item 10,093 and left the room during the discussions. Cllrs J Thomas and P Davies, K Whitehead-Ross, I Whitehead-Ross and Cllr P Fellowes declared an interest in item 10,077. Additionally, it was noted that no Member that had declared an interest in the last meeting took any part in the approval of the minutes for that meeting.
