Independent Remuneration Panel for Wales - Annual Report for 2015.16

Section 10 of the Annual Report of the independent Remuneration Panel for Wales refers to specific provisions relating to payments to Members of Community & Town Councils, Section 12. To the compliance with the Panel Requirements & Annex 4 sets out the Publicity Requirements.

Under Section 151 of the Local Government (Wales) Measure 2011, the Panel now requires that relevant authorities (including Town & Community Councils) must make arrangements for the publication within the authority area of the remuneration received by members & co-opted members. This information must be published & provided to the Panel no later than 30th September 2015, following the end of year to which the payments relate. The following information must be provided about payments made by a Community & Town Council to named members.

- (1) Attendance Allowance
- (2) Financial Loss Allowance
- (3) Payment for costs incurred in respect of telephone usage, broadband etc.
- (4) Allowances made to Mayor/Chair & Deputy Mayor/Chair
- (5) All travel & subsistence expenses & other payment received by each names member & co-opted member of the relevant authority with each category identified separately.

The Report will be publicised locally, on the Council's noticeboards & on the Council's Website.
